The International Initiative for Impact Evaluation (3ie) seeks a candidate to serve as the Deputy Director-Policy, Advocacy and Communications for the International Initiative for Impact Evaluation (3ie). 3ie is dedicated to improving development outcomes through better use of evidence from quality impact evaluations.

3ie's functions are to promote evidence-based policy making and quality impact evaluations, through the funding of new studies, undertaking synthetic reviews of existing studies, providing quality assurance services for impact studies and setting international standards. 3ie's activities identify what development interventions work, and why, and the organization undertakes advocacy to promote better development policies and interventions.

3ie operates as a program of the Global Development Network (GDN), an international organization headquartered in New Delhi, India, which is dedicated toward promoting "Better Research, Better Policy, Better World."

**3ie Strategic Goal:** The Deputy Director - Policy, Advocacy and Communications Office will primarily be responsible for 3ie's strategy of "contributing to building a culture of using new and existing evidence in the development and implementation of policies and programs in low and middle income countries".

## **Key Responsibilities and Core functions:**

The Deputy Director (Policy, Advocacy and Communications Office) will be part of 3ie's management team. He or she will head 3ie's Policy and Advocacy team and the Communications team. The Deputy Director is also expected to take direct responsibility for undertaking some tasks within the PACO team. In addition there will be a representational role for 3ie.

3ie's vision is 'improving lives through impact evaluation'. The first years of 3ie were spent in establishing the programme and building up a base of new research. Going forward, the knowledge management aspect will be become predominant, with 3ie working to become the 'portal of choice' for those wanting to know 'what works in development'.

Specific functions of the role include:

- Lead the development and establishment as the primary portal for evidence-based development
- Direct, advise and help implement 3ie's approach to ensuring the policy relevance and policy impact of 3ie funded studies





- Identify and assist in implementing means of expanding the involvement of low and middle income countries in the work of 3ie
- Management of the day to day work of the Policy and Advocacy team and the Communications team
- Leading on engagement with relevant communities of practice.
- Membership of 3ie's Management Team, and so participating in strategic discussions regarding 3ie's direction
- Working with other members of the management team to ensure efficient communication and coordination.
- Representing 3ie externally both internationally and especially in Asia, especially in meetings involving policy makers from developing countries.
- Contributing data to 3ie's quarterly monitoring system
- Participation in preparation of 3ie's Annual Report
- Undertaking missions to build support for 3ie and gain additional members
- Participating in external meetings as 3ie representative, including making presentations

The Deputy Director (Policy, Advocacy and Communications) will be supervised and evaluated by the Executive Director.

**Duration**: The position is for four (4) years with the possibility of renewal.
